**Items included with puppy:** ACA or ICA Puppy Registration Application, Puppy Food, Toy, Vaccinations and Worming Health Records, If Shipped or Out of State the Puppy will come with a Health Certificate.

**Terms:** Buyer is to pay a \$200 deposit to hold the puppy. Payment in full must be made prior to buyer taking possession of the puppy. All payments made prior to possession must clear our bank prior to puppy being released to buyer. We can accept PayPal and Next Day Money Order. If buyer chooses to pick up puppy, then remainder can be paid only in form of cash.

**Health Guarantee:** The seller certifies that upon delivery to buyer, the puppy has been examined by a veterinarian and appears to be in good health and has received age-appropriate vaccinations and worming, as stated in the accompanying puppy records.

**Limited Warranty:** Buyer must take puppy to the Veterinarian for a Well Health Exam, at buyers' expense, within 72 hours of purchase. Buyer will send Seller a copy of Well Health Exam. If in the opinion of buyer's Veterinarian, there is a problem with the puppy at this time, that is or could be life threatening, the buyer will obtain, and furnish the seller with the Original Veterinarian's letter explaining the diagnosis, as well as the prognosis. If this is the case, seller will give buyer another puppy of equal value. If seller has no puppies available at the time, seller will give buyer another puppy as soon as one becomes available. The puppy the buyer purchased must be returned to the seller immediately, or an Autopsy report stating the cause of death to be the fault of the seller. The seller is not responsible for any shipping charges. Seller reserves the right to have the puppy reexamined by their veterinarian at their cost. Any condition that is minor, correctible, or a breed related minor condition which puppy will likely grow out of is covered. Heat stroke, exhaustion, dehydration, and other health related are not covered in any way. Remember that your puppy can over heat quickly and easily or may die as a result of overheating. He/She must be kept indoors. The seller makes no warranty as to size, color of eyes and coat when puppy is full grown. No warranty is given for any special purpose or function of this puppy. Please remember these puppies are just babies so treat them like one. The seller does not warrant the puppy to be free of common problems such as diarrhea (normally caused by change of food and home), Separation Anxiety, Hypogluacemic (caused from not eating stress) Coccidiosis, or Parasites. The seller cannot be held responsible for Veterinarian bills once the puppy has been released into the buyer's care. The seller cannot be held responsible for contagious disease diagnosed after 72 hours from the date of purchase. Death, injury, or loss of said puppy due to theft, carelessness, recklessness, abuse, neglect, heatstroke, or accident will

not entitle the buyer to any compensation from the seller. Buyers' failure to have puppy examined by a Licensed Veterinarian within 72-hour period voids this warranty.

**The Buyer's Responsibility:** The buyer agrees to take good care of the puppy. Buyer agrees to feed and house the puppy indoors. Buyer agrees to control the puppy on harness or leash when in public and when off the premises of the puppy's home. The puppy's outdoor area will be fenced in and secure, or acceptable provisions will be made to assure the puppy is safe any time he/she is outdoors. Buyer agrees to give the puppy proper physical and emotional care, and to provide basic training and socialization for the puppy.

**Vaccinations:** Your puppy has been started on vaccinations. It is the buyer's responsibility to keep all vaccinations and preventative medicines up to date on the puppy, and do not expose the puppy to any contagious or harmful diseases that may cause illness or death.

**A Forever Home:** It is always our wish that you are the forever home for the puppy. In an event the buyer is unable to keep the puppy for any reason, buyer agrees that under no circumstance is the puppy to be sold to research facility or laboratory.

Any changes to this 2-page contract must be documented and signed by both parties. This contract is a legal binding contract and may be enforced by legal means at the buyer's expense, and all disputes must be settled in Barry County, Missouri. The party acknowledge that they have read and understand and agree to this contract in full by Signing below.
